



## NAB 2026 Contest Rules

### Prizes

- **Two gaming monitors:** OLED, 27", 1440p, 240Hz
- **Two professional monitors:** 27", 4K, color accurate, min. 60 fps

*Note: These are the same monitors displayed and used at our booth to showcase our software during the exhibition.*

### Distribution of Prizes

- **Three monitors** will be awarded to the participants with the **highest number of likes** on individual social media platforms (X, Facebook or LinkedIn).
- **One monitor** will be awarded to the participant with the **second-highest number of likes** across all platforms (two winners may come from the same platform).
- If no eligible entries are submitted on a given social media platform, the prize allocated to that platform will be reassigned to participants on other platforms. In such cases, prizes will be awarded based on the next highest number of likes, regardless of platform. If all entries are submitted on a single platform, all prizes will be awarded to participants with the highest number of likes from that platform.
- A participant may only receive one prize. If a participant qualifies for multiple awards, the higher-ranked prize will be granted.
- Winners will select their preferred monitor type in order of their ranking by likes, starting from the participant with the highest number of likes.
- For the purpose of this Contest, "likes" include all available reaction types on a given social media platform (e.g., "like", "love", "care", "wow" or their equivalents). Each reaction is counted as one like.

### How to Enter

1. Record a video (reel) or create a post at our booth, encouraging people to visit us or test our software.
2. Publish your video (reel) or post on your social media account and tag our official profiles on X (<https://x.com/RemotlyApp>), or on Facebook (<https://www.facebook.com/RemotlyApp/>), or on LinkedIn (<https://www.linkedin.com/company/remotly-app/>).
3. Follow our official social media profiles to be eligible to receive prize notifications.

*Note: Only posts or videos created at our booth and **tagging our official social media channels** are eligible for the contest.*



### Winner Announcement

- Winners will be announced on **Tuesday, April 21, at 11:59 PM PDT** (the third day of the exhibition) via our social media channels, on our contest website: <https://remotly.com/nab/contest> and in direct messages where possible (participants acknowledge that such direct messages may not always be deliverable due to privacy settings or platform limitations).
- All results will be determined based solely on the total number of likes (including all available reaction types on a given platform) that are **publicly visible** on the respective social media platform at **10:00 PM PDT on April 21**.
- By entering the contest, participants agree that the organizer may publish their name and/or username for promotional and announcement purposes without additional compensation, unless prohibited by law.

### Prize Collection

- Prizes must be collected at **our booth W3228 on Wednesday, April 22, at 1:00 PM PDT**.
- Prizes not collected at the designated time and location will be forfeited and will not be awarded to other participants.

### Organizer Protection and Waiver of Claims

1. The organizer reserves the right to make final decisions regarding the interpretation of these Contest Rules, provided such decisions are made in good faith and in accordance with applicable law.
2. Any errors in calculating likes may be corrected by the organizer in good faith, in accordance with these rules and applicable law.
3. Participants agree that they have no right to financial claims, compensation, or appeals in the event of:
  - errors in the calculation of likes or awarding of prizes,
  - loss or inaccessibility of content posted on social media,
  - any decisions made by the organizer regarding the awarding of prizes.
4. All prizes are awarded "as is," and the organizer is not responsible for any defects, damage, or technical issues.

### Additional Rules

- By entering, participants agree that their social media content may be used by the organizer for promotional purposes.
- The organizer reserves the right to disqualify participants who violate these rules or attempt to manipulate likes.
- This Contest is in no way sponsored, endorsed, administered by, or associated with X (Twitter), Facebook or LinkedIn.
- Contest open to individuals 18 years or older who are present at NAB 2026 in Las Vegas, Nevada.
- Void where prohibited.



## **Amendments and Force Majeure**

The Organizer reserves the right to amend these Contest Rules for valid reasons, including technical, organizational, or legal circumstances, provided that such changes do not materially affect the fairness of the Contest or the rights of participants.

The Organizer shall not be liable for any failure or delay in performing its obligations where such failure or delay results from events beyond its reasonable control, including but not limited to force majeure events (such as natural disasters, technical failures, power outages, exhibition disruptions, or actions of third parties).

In the event of such circumstances, including but not limited to damage to equipment or safety concerns at the exhibition booth, the Organizer reserves the right to suspend, modify, or cancel the Contest in whole or in part.

Any such actions will be communicated to participants via the Organizer's official channels.

Nothing in this section shall limit participants' rights under applicable law.
